# SURFACE PREPARATION

The product has very good adhesion to various surfaces. It can be applied over:

- Bare steel and aluminum after flatting and degreasing.
- Zinc coated steel after flatting and degreasing.
- Sanded glass fibre (GFK/GRP), polyester putties, acrylic and epoxy primers, existing coatings in good condition.
- Plastics (excluding PP and PE).

We recommend sandpaper with gradations: P80÷P120.

**Caution:** Do not apply the putty directly on the reactive primers, 1K acrylic and nitrocellulose products.

- 2K polyester spray fillers.

- system.The rooms should be well ventilated.
- Clean the guns and equipment immediately after use.
